Old Business addressed: new ASDAL Website, audit procedures. New Business addressed: ASDAL address of record request of Union College; resignation of European and Inter-American chapter coordinators.

Distance Education Coordinator: Ann Greer (email) – In anticipation of the 2008 LLU Conference, this year's *From a Distance* column focused on Medical Librarianship.

Publicity Coordinator: Christy Berry – Notice of ASDAL 2007 was placed in these North American Division papers: Southern Tidings, Visitor, Southwestern Union Record, Lake Union Herald, Pacific Union Recorder, Mid-America Outlook, Gleaner. School Library Section: Katye Hunt – Most of the attendees were from academic libraries. One new ASDAL member was sent by their Union conference.

Constitution and Bylaws Committee: Tony Zbaraschuk – Working on rewrite of Overseas Coordinator and some other cleanup.

Scholarship and Awards Committee: Cynthia Helms – The committee worked on the Silent Auction, promoting the Hilts Scholarship by writing articles about recipients for *ASDAL Action*, preparing guidelines for the Outstanding Lifetime Achievement Award, and revising the Hilts Scholarship application form. A \$1200 scholarship will be awarded this year.

SDA Classification Advisory Committee: Stan Cottrell (email) – New SDA call number schedules edited by Felipe Tan will be posted on the ASDAL web site. New wording is requested on Article VI, Section 1 of the Bylaws to reflect current workings of the committee.

SDAPI Board: Jim Ford – Financially, the Index is OK. Indexing of the Review and Herald is going back retrospectively at the rate of 4 years per year. Two new titles now indexed are the Journal of Applied Christian Leadership and the Journal of Adventist Mission Studies. General interest articles from AU, LLU, and SAU alumni offices will be indexed in the future.

Site Planning Committee: Ralph Koëhler – ASDAL 2009 will be at Andrews University June 21-25. The 2010 conference will be at Oakwood and Pacific Union College will be the location of the 2011 conference. AIIAS has extended an invitation for ASDAL 2012.

Statistics Committee: Lauren Matacio – Statistics were received from 13 NAD schools and Avondale College.

Presentation: "Wikipedia, Citizenpedia, Scholarpedia, Whatnextapedia," Sheila Clark, Canadian University College. Comparison of collaborative online encyclopedias and ways to encourage students to use quality library resources.

**Breakout Session Reports:** 

Technical Services discussed storage, archives, technology, and the need for collaboration.

Archives and Special Collections discussed space, the need to generate interest in preserving special materials, non-professional staff, relationship with E.G. White Estate, how to collect and handle 3-D items.

Systems/Information Technology discussed technical issues with scanning GC archives and other technical questions.

School Librarians discussed format for the next conference and ways of promoting their section.

Public Services discussed time management, keeping up with change, assessment, problems with technology, and children in the library.

Presentation: "Circling the Trends in Serials & eResources," Shirley Rais, Loma Linda University. Highlights from Charleston Conference, Electronic Resources & Libraries, and NASIG.

**Business Session II:** 

Committee and Coordinator Reports:

Rank & Tenure Committee: Deanna Stevens – Working on a survey of scholarly/creative activity for scholarship. They recommend that the Boyer Model be supported by ASDAL because it is a more inclusive definition of scholarship.

ALICE Council: Paulette Johnson – Net income of \$30,000 and \$230,000 in database sales. There are currently 13 databases from 4 vendors. Southwestern and Helderberg joined ALICE. They are working toward better cooperation with the General Conference to obtain databases for international libraries and with the North American Division for K-12 schools. A document will be presented in the fall.

Professional Recruitment Ad Hoc Committee: Christy Berry – Library directors were surveyed to identify problems filling vacancies. Results showed the mean time to fill a vacancy was 6 months due to difficulties related to finances, location, or training. Suggestions for recruiting were to work with administration to gain financial assistance for individuals working on a master's degree and to provide materials to promote librarianship at local career fairs.

Library Manual Ad Hoc Committee: Annette Melgosa – The projected is being funded by the General Conference. A sum of \$7,750 has been received for development. They will pay for layout and printing. A copy editor has been secured. Annette will be the content editor. It will be translated into Spanish and as needed by Divisions. Motion: Library Manual Committee become a standing committee. VOTED. Motion: Membership of committee will continue as is. VOTED. The committee will recommend terms which will be referred to Executive Committee.

European Chapter: Unfilled. Per Lisle resigned. ASDAL Europe was postponed to 2009.

African Chapter: Bola Atulomah. Reorganization is occurring because of Wendy Young's retirement. Currently there are 35 members and plans are underway to connect the librarians in African SDA institutions of higher education. Bola Atulomah is now Chapter Coordinator.

Inter-American Chapter: Heather James (email). This chapter was formed in 2007 after the formation of Biblioteca Virtual Adventista (<a href="http://www.interamerica.org/bva/">http://www.interamerica.org/bva/</a>. Reports were received from University of the Southern Caribbean (USC) and Northern Caribbean University

(NCU). Enrollment has gone up at USC because the government now subsidizes tuition. An integrated library system is in operation with increased e-content. Other improvements: collection, more staff, conversion to LC call numbers, increased computers, new Web site.

NCU. Heather Rodriguez-James moved to Oakwood College. Grace Carr-Benjamin is the new Director. Improvements: joined Adventist Virtual Library consortium, created educational displays, conducted library orientation for 40 classes, added more computers, established liaison librarians to better serve faculty, acquired new furniture. They are also upgrading their web site, brochures, and reviving the library newsletter.

#### **Unfinished Business:**

Treasurer Audit: Because of the cost, it is not feasible to have an external audit of the books, but we must have procedures in place which guarantee finances and the integrity of the treasurer. Books will be automated. Carlene Drake and Lori Curtis will setup guidelines and procedures for an internal audit.

Lifetime Achievement Award: Guidelines were presented by Cynthia Helms. Modification were discussed. Motion: Accept with corrections. VOTED.

Campus Tour: Richard Schaffer, Historian, Loma Linda University. Slide presentation on history of Loma Linda University.

Breakfast and Devotional: Warren Johns, Loma Linda University, inspired us while sharing stories from his family's history.

Keynote Address: "Library and Information Systems: Marriage, Dating, or Just Friends," D. P. Harris, Vice Chancellor, Information Systems, Loma Linda University. Though librarians and information systems personnel may look at things differently, we can agree on shared objectives and commitment to teaching, research, and service. If disagreements come, work them out. Collaboration, caring, trust, and respect are important, as are forgetting stereotypes and creating opportunities to socialize together.

Presentation: "Towards an Adventist Discography: Initial Thoughts, Hopes, and Plans," Lori Curtis, Loma Linda University. Demonstration of the Web site that inspired this project, plans, and examples from Loma Linda University.

Presentation: "How Library Resources and Services are Marketed at Northern Caribbean University," Grace Carr-Benjamin, Northern Caribbean University. NCU is currently marketing the library's resources through brochures, user education, newsletter, and their Web site.

"Is the Future Here Yet: Management Trends in Academic Libraries," Cynthia Helms & Silas Marques de Oliveira, Andrews University. Library function has not changed, but techniques have changed. The infrastructure of the future must have a flexible structure, be cost-efficient, provide a higher level of service, and meet research and development competencies. Understanding the new paradigm, communication, and employee participation and continuing education will help libraries deal with change.

"Social Networking Tools and Other Emerging Technologies," Elisa Cortez, Loma Linda University. Demonstration of Web 2.0 technologies such as Del.icio.us and Pageflakes to connect users with library services.
